#### 8. Criteria for Selection:

- (a) Candidates qualifying in stage I shall be eligible to appear for test in stage II.
- (b) Only such candidates, who qualify in each papers of Stage II shall be considered for preparation of the final merit list.
- (c) Final merit list of the qualified candidates shall be prepared on the basis of total marks secured by the candidates in both the stages of Examination.
- (d) After arranging the candidates in order of merit as per (c) above, number of candidates to be declared successful shall be equal to the number of vacancies in each category.
- (e) In the event of any vacancy notified for recruitment remains unfilled only due to non-joining of selected candidate, the next candidate in the merit list shall be considered for appointment. However, appointment of such candidate shall be only on the ground of refusal/ declining offer of appointment and no wait list or approved panel shall be maintained.

Note: The date and venue of the tests will be intimated separately to the eligible candidates.

No intimation will be sent in respect of other applicants who are not eligible.

- 9. Disqualification: No person, -
- (a) Who, has entered into or contracted a marriage with a person having a spouse living; or
- (b) Who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the said post.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this Rule.

10. Application fees: Along with application form and Indian Postal Order for Rs 100/- or UCR receipt to be taken in any post office should be enclosed towards application fee. SC/ST/ candidates are exempted from fees.

#### 11. Disclaimer:

- (i) The Department of Posts reserves the right to cancel this recruitment process at any time/stage without assigning any reason.
- (ii) The vacancies notified are subject to change without assigning any reason.

#### 12. Special instructions to the candidates:
