With reference to Worthy Engineer-in-Chief, Jal Shakti Vibhag, Jal Shakti Bhawan Shimla-5 letter No JSV-ES-III-D.W-Manpower-Vol-VIII/2025-8504-08 dated 24-03-2026, 29-33 dated 06-04-2026 and 475-79 dated 20-04-2026, which were further endorsed by Superintending Engineer, Jal Shakti Circle, Dehra vide endorsement No. SE/JSCD/EA-1/D.W. Manpower/2026- 352-54 dated 21.04.2026, 450-52 dated 24.04.2026 and 18.05.2026, vide which invited for filling up 30 Nos. Post of various categories i.e. **08 Nos. of Para Pump Operators, 02 Nos. of Para Fitter and 20 Nos. of Multipurpose Worker.** Accordingly Application from desirous candidates are invited for filling up of the posts of Para Pump Operator, Para Fitter and Multipurpose workers under JSV Division Jawalamukhi, on the term & conditions that they will be part time worker for 6 working hour per day. The application should reach in the office of undersigned on or before **18.07.2026**. The application received after due date or found incomplete will be rejected straightway without assigning any reason.

Candidates are required to submit the required documents of SC/ST/OBC categories and latest EWS categories certificate to get the benefit of reservation under SC/ST/OBC/EWS category.

Age limit:-The age limit for applicant shall be >18year and < 45 years.

Eligible and interested candidates can submit their application on Prescribed Performa in the Office of the **Executive Engineer, JSV Division Jawalamukhi** on any working day from 10.00 am to 5.00 pm up to 18.07.2026 with following attested/self-attested documents:-

- (i) Legitimate proof of age.
- (ii) Proof of income in case of BPL candidate, issued not later than six months.
- (iii) Proof of educational and technical qualifications.
- (iv) Certificate of Bonafide Himachali.
- (v) Character certificate issued not later than one year.
- (vi) Experience certificate in the related field of JSV/HPPWD/CPPWD/PSUs/ or outsourcing agency providing service in HP Jal Shakti Vibhag.

(vii) Caste/Category Certificate(SC, ST, OBC)

(viii) Economical Weaker Certificate (EWS) issued by the competent authority not older than six months. Application received after 18.07.2026 will summarily be rejected. Initial seniority shall be drawn as per criteria notified and candidates will be called for skill/physical test will be informed separate by telephonically/letter or through media i.e. print/electronic.



SKILL TEST

(A) Experience for the post of Para Pump Operator, Para Fitter and Para Multipurpose worker:-

Experience of the related field of IPH/HPPWD/CPPWD/PSUs or Outsourcing agency providing service in HP Jal Shakti Vibhag. A certificate issued by the EE(JSV) is required. Related field or Pump Operator is operation and maintenance of Pumping machinery allied electrical installations of Rural Water Supply Schemes.

FOR PUMP OPERATOR

1. Minor repair of pump, basic knowledge to locate faults or damage, replacement of defective parts and sets them in position.
2. Knowledge of test pressures, leakage etc. to make necessary adjustment and observation of performance for appropriate yield of water.
3. Knowledge of pumps installation at site and connect to motor, basis alignment of pump to motor and tools i.e spanner & keys etc.
4. Ability to locate faults in electric system and motor.
5. Ability to Dismantles or partly dismantles and remove damaged or worn out part and its replacement, greasing and oiling of moving parts.
6. The knowledge of pump lubrication and cooling system.
7. The ability to operate regulating valve and control mechanism of pumping system.

FOR PARA FITTER


1. Ability to repair water supply pipe lines, arrest its leakage, adding new connection r abandoning defunct connection.
2. The basic knowledge of pipe fitting, its sized, operation and maintenance.

3. Ability to cut threads on pipes using ratchet and die sets, fitting of specials on pipes using basis tools.
4. Knowledge of basic operation involved in managing in-village water supply infrastructure, pipe distribution layout and techniques of flow regulation to ensure equitable distribution of water in hilly terrain.
5. Knowledge of tools used for pipe fitting and its operating skills.
6. Behavioural skill in handling grievances/complaints and conflict resolution.

PHYSICAL TEST

1. He should be capable to carry tools and pipes in hilly areas.
2. He should have not any physical disabilities and colour blindness.


